Thanks to successfully fulfilling numerous government contracts, including several high-profile ones in the military, HCRS’ revenues soon skyrocketed: \$7.5 million in 2004; \$12 million in 2005 and a projected \$20 million this year.

Ms. Doles will be honored at a *Washington Business Journal* reception today at the Four Seasons Hotel in Washington, DC. She is being recognized as one of the women who has “made a difference in her community, blazed a trail for the rest of us, and is leaving a mark on Washington business.”

“I am happy to receive this recognition as a woman entrepreneur, since it gives me an opportunity to acknowledge the incredible team who is supporting the growth of my business,” Ms. Doles says. “You can’t be a ‘woman who means business’ without a lot of outstanding men and women working alongside you to make a success of your company.”

This is the second high honor to be bestowed upon Ms. Doles in 2006. Earlier this year, she was named a finalist for the Ernst & Young Entrepreneur Of The Year<sup>®</sup> 2006 Award in the Maryland Program.
